

## Announcement pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 2 Austrian Stock Exchange Act - Changes of significant shareholdings

Erste Group Bank AG informs the public pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 12 October 2016 held 16,244,170 or 3.78% of voting rights attached to shares (previously 3.90%) and 422,419 or 0.10% of voting rights through financial instruments (previously 0.10%) in Erste Group Bank AG (rounded stake in share capital of 3.88% compared to previously 4.01%), thus combined less than 4% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
