

## 2<sup>nd</sup> announcement pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 2 Austrian Stock Exchange Act - Changes of significant shareholdings

Erste Group Bank AG informs the public pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 29 December 2016 held 17,345,849 or 4.04% of voting rights attached to shares (previously 3.97%) and 127,044 or 0.03% of voting rights through financial instruments (previously 0.03%) in Erste Group Bank AG (rounded stake in share capital of 4.07% compared to previously 4.00%), thus combined more than 4% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
