

2nd Announcement pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 2 Austrian Stock Exchange Act - Changes of significant shareholdings

Erste Group Bank AG informs the public pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 20 April 2017 held 16,877,314 or 3.93% of voting rights attached to shares (previously 3.95%) and 221,563 or 0.05% of voting rights through financial instruments (previously 0.05%) in Erste Group Bank AG (rounded stake in share capital of 3.98% compared to previously 4.01%), thus combined less than 4% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
