

Announcement pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 2 Austrian Stock Exchange Act - Changes of significant shareholdings

Erste Group Bank AG informs the public pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 23 November 2017 held 21,526,669 or 5.01% of voting rights attached to shares (previously 4.98%) and 854,261 or 0.20% of voting rights through financial instruments (previously 0.20%) in Erste Group Bank AG (rounded stake in share capital of 5.21% compared to previously 5.18%), thus combined more than 5% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
