

## Announcement pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 2 Austrian Stock Exchange Act - Changes of significant shareholdings

Erste Group Bank AG informs the public pursuant to sec. 93 Austrian Stock Exchange Act in connection with sec. 91 art. 1 Austrian Stock Exchange Act that BlackRock, Inc., Wilmington, United States of America, as of 27 November 2017 held 21,825,181 or 5.08% of voting rights attached to shares (previously 4.99%) and 461,774 or 0.11% of voting rights through financial instruments (previously 0.19%) in Erste Group Bank AG (rounded stake in share capital of 5.19% compared to previously 5.19%), thus combined more than 5% of Erste Group Bank AG's share capital (EUR 859,600,000 divided into 429,800,000 voting no-par value bearer shares – ordinary shares).
