Balance per LTV-band

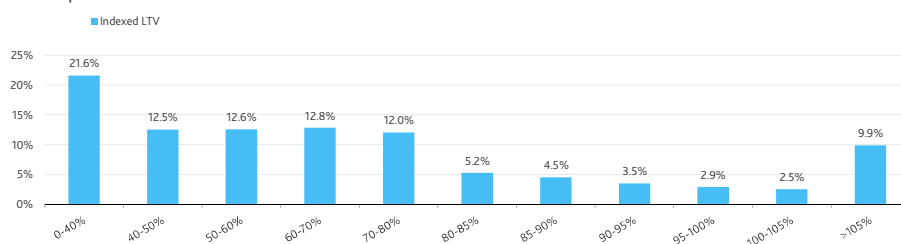

Percentage of residential assets

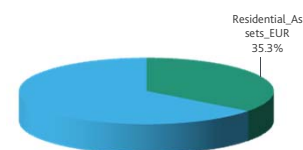


Chart C:
Time line evolution of pool's LTV

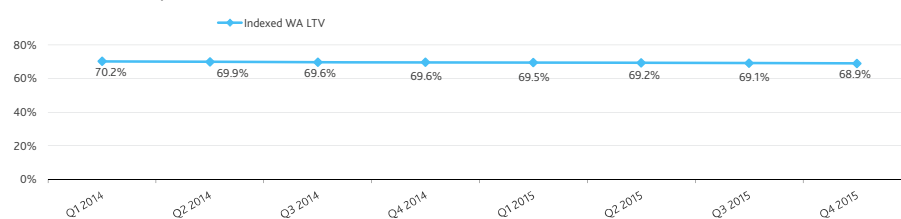

Interest rate type

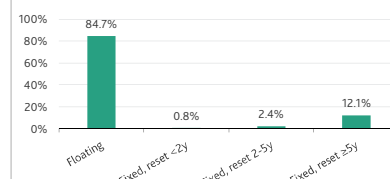


Chart E:
Main country regional distribution

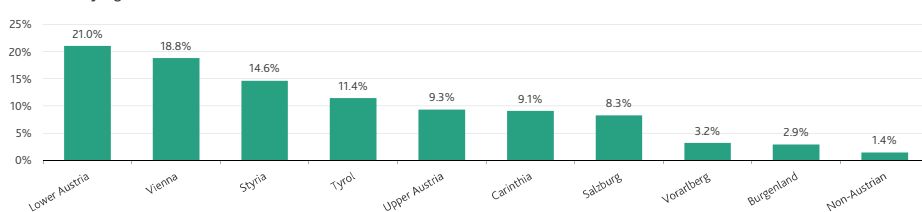
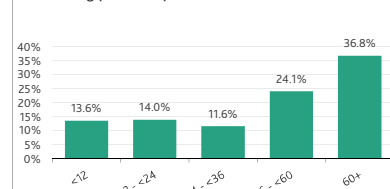


Chart F:
